- Before the weather gets too hot and storm season gets upon us please consider having your trees trimmed and your driveways, sidewalks and walkways cleaned. Also check the exterior of you home if there is discoloration now is the time to take care of that too.
- No Parking on the Streets over night (12 am-7am) If you must park on the street durring the day do not park directly across form another vehicle or a resident driveway. Parking over sidewalks is always against the rules and the law. No Commercial Vehicles can be parked/stored on property.
- Waste Management picks up household and yard waste as well as recycling on Mondays. They pick up household waste a second time on Thursdays. Cans should be stored in the garage or on the side of the home behind a screen or planting so not clearly visible from the street.

Updates:

- Entrances Signage and Marquee update is complete. There are some challenges with the irrigation at the south entrance that has slowed down progression due to lack of known water source. Working with the county and state governing agents as a well as contractor and neighboring community all options are being explored to ensure succusessful and sustainable outcomes. Because of how the contract for the landscape and contracted and priced we can not break the entrances up with out increasing the cost but we assure you the wait will be worth it and your patience is appreciated.
